Message from the Chair Paul A. Gore

Happy Birthday SVP! This year we celebrate our 20th year as a group of organized professionals committed to promoting and facilitating contributions to research, teaching, practice, and public interest in vocational psychology and career interventions. This seems like a very appropriate time to reflect on our accomplishments as a Society and on our exciting future.

In our 20 year history, we have sponsored 7 biennial conferences (Michigan State University, 1992; The Ohio State University, 1994; Lehigh University, 1997; University of Wisconsin-Milwaukee, 1999; Houston Texas, 2001; Coimbra Portugal, 2003; and University

of British Columbia, 2005). We have convened in smaller groups to discuss our response to important policy decisions (e.g., School-to-Work Transition meeting) and to break bread in the historic Civic Service House in Boston. Through these experiences we have built a community – not just a community of scholars, but a community of friends. I certainly have many fond memories of my interactions with Society members and I suspect many of you do as well.

I would argue that the primary beneficiaries of our “community” are graduate students and new professionals - a group we have been committed to since our inception and will continue to support and nurture in the future. Our community continues to grow with Society membership is rapidly approaching 400. Most of our newest members are graduate students. To further advance our agenda of involving graduate students in the Society, we recently installed our first two SVP graduate student representatives, Ryan Duffy, and Neeta Kantamneni. We look forward to their guidance on issues of importance to the next

generation of Society members and leaders.

Our ongoing efforts to infuse Vocational Psychology into the mainstream continue to pay off. Three of our distinguished members (Camille DeBell, Donna Schultheiss, and Cindy Juntunen) recently authored a series of manuscripts in *Professional Psychology: Research and Practice*. These papers describe the current nature of work, the interface of work and family, and how to promote the integration of work and personal issues in the psychological practice. This journal targets a broad audience and has the third largest subscription base of all APA journals. Additionally, I would like to acknowledge Nadya Fouad’s recent contribution to the *Annual Review of Psychology* entitled

Work and Vocational Psychology: Theory, Research, and Applications. Nadya's work is one of only 6 or 7 contributions addressing vocational psychology and career development in the history of this series.

Our community has much to look forward to. This year, for example, the SVP Board has worked hard to extend our community of friends and colleagues by collaborating with related organizations. For example, SVP will present a pre-conference workshop at the NCDA conference in Seattle Washington in July. SVP will also be recognized as a collaborating organization at that conference. The SVP Board is working hard to help plan and implement the IAEVG/NCDA/SVP Symposium in Padua Italy next September. This is a very exciting event that should be of interest to every SVP member. I urge you to consider joining us in Italy (more information can be found at <http://iaevgconference07.psy.unipd.it/>). Further, our recently formed Social Action Committee is engaged in dialogue with several groups in an effort to provide SVP members with outreach opportunities. Linda Subich, Paul Hartung, and their colleagues have put together an excellent program for our next Biennial Conference in Akron Ohio (May 30 – June 1, 2007; <http://www3.uakron.edu/psychology/svp/>). More information about this conference can be found on page 3. In an effort to further extend our community of colleagues, we

recently proposed an APA symposium entitled "Interdisciplinary Perspectives on Vocational Psychology." Finally, the Society plans on taking a very active role in helping to shape the 2008 International Counseling Psychology Conference in Chicago (March 5 – 9, 2008; <http://www.internationalcounselingpsychology.org>) and we are exploring the possibility of offering a one day Society pre-conference prior to this event.

As a community of friends, we also mourn the losses of our colleagues and their families. Many of us were deeply saddened recently to hear of the unexpected death of Mr. Curt Schultheiss, husband of our Chair-Elect, Donna Schultheiss. On behalf of the Society and its members I would like to extend our deepest condolences to Donna, her three children, and their extended family.

As a graduate student sitting in the audience of the first SVP conference in 1992, I never imagined this future. I want to extend my gratitude to the SVP members and the Board for supporting me during my first 6 months as Chair. I am excited about where we are as a Society, and about our potential to advance our efforts in coming years. Call For Proposals SVP

Society of Counseling Psychology (APA Division 17) Student Poster Session

American Psychological Association Convention San Francisco, California, 17-20 August 2007. Submission Deadline for Proposals: 20 March 2007

Proposals are now being accepted for a Student Poster Session co-sponsored by the Council of Counseling Psychology Training Programs (CCPTP), Division 17 Sections, and the Student Affiliates of Division Seventeen (SAS). Poster proposal may be empirical studies or theoretical considerations relevant to career development or vocational psychology. **The first author on the proposal must be a student (or have completed the project while a student or intern) and must either be an affiliate of Division 17 or sponsored by a Division 17 member.**

Poster proposals should include a **cover sheet and a 500- to 1000-word summary** of the study in APA style. The abstract should include some description of the nature of the presentation (empirical, theoretical, technique) and primary findings. Summaries of empirical studies should include a brief literature review, statement of the problem (hypotheses or research questions), participants, procedures, results, and conclusions. Summaries of other presentations should include enough detail for reviewers to judge the overall format and

contribution of the scholarship. The proposals will be subjected to masked review. Please **do not include identifying information** in the proposal (only on the cover sheet).

Please submit your proposal and completed cover sheet as attached files to Saba Ali at saba-ali@uiowa.edu.

Finally, identify in the subject line of the email: student poster proposal – "Name of Section" (e.g., student poster proposal – SERD). See <http://www.div17.org/sectionposter> to download the Call for Proposals and Proposal Cover Sheet. **Notifications of proposal status and presentation instructions will be sent via email on or before May 14, 2007.**

In that this poster session is internally sponsored by Division 17, and not part of the official APA convention program, presenters will not be eligible for APA travel awards or waived registration fees for the APA Convention.


Society Spotlight

ACT[®]**Summer Internship Program 2007**

ACT sponsors a Summer Internship Program, offered annually to outstanding doctoral students interested in careers related to assessment and educational studies. The eight-week program provides interns with practical experience through completion of a project, seminars, and direct interaction with professional staff responsible for research and development of testing programs and other educational services. The program is also intended to assist in increasing the number of women and minority professionals in measurement and related fields. Applicants must be enrolled in and attending an institution within the United States.

Duration: The 2007 program will begin June 4 and end July 27.

Location: Interns will work at ACT's national headquarters in Iowa City, Iowa.

Financial Support: Interns will be paid a stipend of \$5,000 and round-trip transportation between their graduate institution and Iowa City. A supplemental living allowance of \$400 is available when a spouse and/or children accompany the intern to Iowa City.

Types of Internships: Four categories of internships are available. Qualified candidates may apply for more than one category, if interested.

Several Internships are available in:**Psychometrics and Statistics**

Psychometric and Statistical interns will participate in analysis of real or simulated data in areas such as equating, computer-based testing, validity, reliability, test theory, and score reporting. To qualify, candidates must be doctoral students currently enrolled in measurement, statistics, educational and/or quantitative psychology, or related programs.

Internships are available in the following applied research areas:**Education and Workforce Research Services**

Interns will participate in analysis of school and workforce programs, policy issues, and/or intervention strategies as they relate to college readiness, retention, remediation, and workforce training and success. To qualify, candidates must be doctoral students currently enrolled in educational, organizational, and/or industrial psychology, evaluation, educational policy, educational measurement, or related programs.

Industrial-Organizational Psychology

Industrial-Organizational Psychology interns will participate in analysis related to employers' personnel practices and their use of ACT's products and services. Work may involve synthesis of job analysis data from multiple employers and/or assistance with consulting projects, which could range from competency modeling to the development of test blueprints. To qualify, candidates must be doctoral students currently enrolled in industrial-organizational psychology graduate courses or related programs.

Career and Vocational Psychology

Vocational Psychology interns will participate in analysis related to career interest, values, and skill assessments, evaluation of career interventions, computer-assisted career guidance, and college and career readiness. To qualify, candidates must be doctoral students currently enrolled in counseling psychology, counselor education, or related programs.

To Apply: Submit the completed application form, your statement of interest and experience, your vita, a clear official copy of your graduate and undergraduate transcripts, and two letters of recommendation from persons who are familiar with your academic work and professional background.

The other primary qualification is the desire to act as a steward for and to contribute to the ongoing development of the section. Willingness to stand for election as Communications officer involves making a two year commitment to the section. The newly elected communications officer will take over the responsibilities of the office at the annual APA convention in San Francisco in August 2007.
